Government Scholarship


The Maharashtra State Government's Social Welfare Department provides scholarships/free ships for students belonging to categories such as SC, SBC, OBC, VJ, NT, DT, and EBC through various schemes including the Rajshri Shahu Maharaj Education Fee Scholarship Scheme, Dr. Punjabrao Deshmukh Subsistence Allowance Scheme, State Government Minority Scholarship, EWS, DPDHMA, and Integrated Tribal Department Scholarship/Free Ship for ST, PDUHMA. The state government invites applications through public notification. Eligible students apply via the scholarship portal <https://mahadbtmahait.gov.in> using their student login credentials. Colleges accept, verify, and forward the applications to the District Social Welfare Department, which then forwards them to the Directorate of Scholarship Department for reimbursement. Subsequently, the state government disburses the scholarship amount directly to eligible candidates based on fund availability.
